# 16 Highways / PROW Matters

- After reporting of a knocked down bollard in the parish, it has now been replaced.
- Highways have agreed to provide kerbing on Aston Ingham Road between Glendalough and the junction with B4221 to prevent water build up and damages.
- Awaiting response from FoDDC about the road name change from Wood Lane to Stony Lane.
- PROW meeting took place about the Bridge, PROW officer agreed to investigate quotes and is waiting on responses and funding opportunities. Cllr GP will follow up with PROW officer.
- Proposed weight limit on the B4221, No update on the TRO to provide a weight limit on the B4222. NW to continue to chase with the Herefordshire District Councillor.
- Council discussed arranging a date for use of the speedwatch gun, this will be discussed and arranged by email.

# 17 Planning Decisions

Clerk to check on status of planning applications in the Parish. Council unsure if any applications are outstanding. Cllr NW to communicate with planning about the status of the Parish as a settlement without boundaries.

Council agreed for Clerk to proceed with replacement of the disk and agreed to a cost of up to £50, if costs will be any higher Clerk to bring back to Council before proceeding
